



**Israel Extreme Adventure Camp
2019 (IEAC)
Registration Terms**

Camp Dates: June 30-July 11, 2019

PAYMENTS

1. The \$450 non-refundable deposit is required at the time of registration. Registration for camp will not be considered final until the tuition is paid in full.
2. The first half of the payment balance is due by March 1, 2019 and the second half of the balance is due by May 1, 2019. Tuition must be paid in full by May 1, 2019.
3. Any late payment after May 1, 2019 will result in a \$75 charge.

CHANGES/CANCELLATIONS/REFUNDS

4. Cancellations before April 1, 2019 will be eligible for a full refund, minus the \$450 non-refundable deposit.
5. Cancellations between April 2 and April 30, 2019 are required to pay 40% of the camp cost.
6. Cancellations between May 1 and May 31, 2019 are required to pay 70% of the camp cost.
7. Cancellations made from June 1 are required to pay 100% of camp cost.
8. Cancellation requests must be sent via fax or email, and will be followed by a confirmation message.
9. Opening of IEAC 2019 is dependent on the number of registered campers.
10. No refunds will be given due to late arrival, early departure, or expulsion from camp. Camp management holds the right to expel campers, with no refund, if behavioral or ethical norms are not followed.
11. In case of an early departure due to a medical condition, upon discretion of our medical staff or for any other medical reason, you will be given a refund equal to 40% of the relative period that was not utilized, out the session tuition paid. No refund will be given in cases where there are less than 4 days remaining of the camp session.
12. Any refunds will be made by the end of September 2019.

HEALTH AND INSURANCE

13. Parents or guardians must notify the camp management during registration of any special medical condition, allergies or disabilities of their child. The camp reserves the right to decline camper's participation if the administration feels that IEAC cannot accommodate a specific medical condition.
14. For campers living outside of Israel, Health Insurance through Harel Insurance must be obtained for the camper before May 20, 2019.
15. Campers must also provide proof of personal medical insurance, which must be emailed or faxed to Israel Extreme by June 10, 2019.
16. Every medication used by the camper has to appear clearly on the registration form.

MISCELLANEOUS AND STATEMENTS

17. Camp management is not responsible for damage made by any camper to either camp property or to property of a third party. In case of damage, the camper and his/her guardian will be charged accordingly.

18. Camp management is not responsible for any loss or damage for camper belonging or equipment in his/her care.

19. By registering for IEAC, I hereby give my approval to share my child's flight information with the other registered campers in order to coordinate pick-ups and drop-offs.

20. By registering for IEAC, I hereby give my approval to use any picture, video, recording and digital products of my child for promotion and marketing purposes.

21. By registering for IEAC, I hereby give my approval for Israel Extreme to send my child newsletters and updates via email, internet, social networks and mobile phone.

22. A copy of the camper's passport must be sent with payment.
